This privacy statement discloses the privacy policies for NightDriveSafaris (Pty) Ltd.

## **2. Information Collection and Use**

NightDriveSafaris (Pty) Ltd is the sole owner of the information collected on this website. We will not sell, share, or rent this information to others in ways different from what is disclosed in this statement. NightDriveSafaris (Pty) Ltd collects information from our users at several different points on our website.

## **3. Information We Collect**

### **3.1. Non-Personal Information**

Non-personal information, data about usage and service operation, not directly linked to a specific person may be collected to analyse how the website is used by visitors to the website.

### 3.2. Aggregate Information

Pages viewed, IP (Internet Protocol) addresses, referral data are all examples of aggregate information which your computer provides to us when using/accessing this website.

### 3.3. Personal Information

This website uses personal information of its users such as one's name, e-mail address, business name, social media profiles, user IDs, passwords, billing information, address as well as one's business particulars. ## **4. How will your information be used?**

4.1.
